**ORDER**

NOW, this 5th day of February, 2019, upon consideration of defendants' objections to a proposed third-party subpoena under Pennsylvania Rule of Civil Procedure 4009.21, as well as Francis X. O'Connor, Esquire's Personal Objections to the same proposed subpoena, and after oral argument on said objections, **IT IS HEREBY ORDERED AS FOLLOWS:**

1. Defendants' objection to the proposed third-party subpoena is **SUSTAINED.**<sup>1</sup>

<sup>1</sup> Pennsylvania Rule of Civil Procedure 4003.8(a) provides guidance as to when pre-complaint discovery is permitted: "A plaintiff may obtain pre-complaint discovery where the information is material and necessary to the filing of the complaint and the discovery will not cause unreasonable annoyance, embarrassment, oppression, burden or expense to any person or party." *Id.* (emphasis added). Where a plaintiff has sufficient facts to plead a *prima facie* case without pre-complaint discovery, then pre-complaint discovery will not be granted. *See Pa. R. Civ. P. 4003.8(b)* (noting that court may "require the plaintiff to state with particularity how the discovery will materially advance the preparation of the complaint"); *McNeil v. Jordan*, 894 A.2d 1260, 1278 (Pa. 2006) (Baer, J., joined by Castille, J.) (proposing that a plaintiff must aver that "but for the discovery request, he will be unable to formulate a legally sufficient pleading"); *Pelzer v. Wrestle*, 49 A.3d 926, 931 (Pa. Commw. 2012) (upholding the denial of pre-complaint discovery that was unnecessary for the "formulation of a civil complaint").

Through the briefing and oral argument, it was disclosed that this dispute centers upon the validity of the signature of the decedent, Arthur C. Martin, Sr., upon a deed that conveyed his 200 acres of real property in equal shares to his children. Counsel for plaintiffs indicated that prior to his death decedent repeatedly disclosed that he never signed the deed. As a result of those

representations, plaintiffs' counsel retained a hand-writing expert to review the deed and the expert has concluded that the signature on the subject deed was not the signature of decedent. During oral argument, plaintiffs' counsel conceded that the expert report, coupled with the representations of decedent, constituted sufficient grounds to file a civil complaint challenging the validity of the subject deed. This concession undercuts any further argument that pre-complaint discovery is necessary.

Understandably, plaintiffs' counsel seeks pre-complaint discovery in an effort to obtain as much information as possible as to the circumstances surrounding the execution of the subject deed prior to filing a civil complaint that alleges a forged deed that was notarized by a fellow attorney. Plaintiffs' counsel candidly indicated that he was seeking a reasonable explanation to provide to his clients as to what occurred in connection with the execution of the subject deed, i.e., some facts to demonstrate that the deed was not forged despite the determinations of the handwriting expert. Plaintiffs' counsel's motivation for the third-party subpoena, however, was not based upon a need to obtain additional information necessary for filing a civil complaint; rather, it was motivated by professional courtesy to a colleague in the hopes of avoiding the need to file potentially embarrassing litigation through the exchange of information. While plaintiffs' motivation is commendable, defendants have objected to the pre-complaint discovery. Based upon plaintiffs' counsel's concession that he has sufficient information to allege that decedent's signature was forged on the subject deed, defendants' objection to pre-complaint discovery is sustained.

2 Under Pennsylvania Rule of Civil Procedure 4009.21(c), a party to the action has standing to file an objection to a proposed subpoena. Moreover, Rule 4009.21(b) further provides that the third party is not to be initially provided with a copy of the proposed subpoena. The proposed subpoena is only served upon the third party if there is no objection from any party to the litigation or, if objections are raised, then the third-party subpoena cannot be served until the court has resolved the objections. Pa. R. Civ. P. 4009.21(d)(1)-(2). As such, Francis X. O'Connor, Esquire, lacks standing at this point to file any objections to a proposed third-party subpoena that has not yet been served upon him. Because no party objected to his participation in oral argument, the court allowed Francis X. O'Connor, Esquire to participate in oral argument. Defendants' counsel adopted the arguments made by Francis X. O'Connor and those arguments have been considered solely as they relate to defendants' objections to the proposed subpoena.
