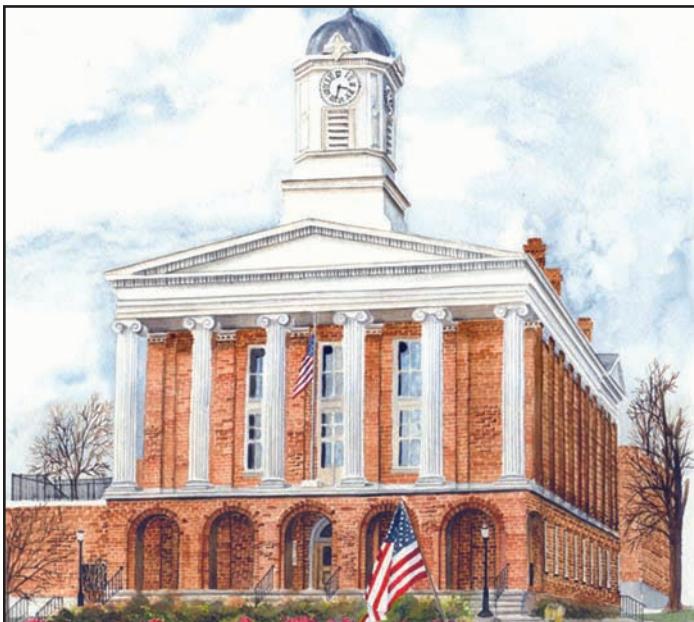

ORDER

NOW, this 28th day of June, 2016, after a hearing held on June 20, 2017 on defendant Richard Clark's petition to set aside sheriff's sale dated April 25, 2017, **IT IS HEREBY ORDERED THAT:**

1. Defendant's petition to set aside sheriff sale dated April 26, 2017 is **DENIED.**¹

¹ Pennsylvania Rule of Civil Procedure 3132 provides a trial court with the discretion to set aside a sheriff sale "upon proper cause shown" provided such action is "just and proper." Defendant bears the "burden of proving circumstances warranting the exercise of the court's equitable powers." Nationstar Mortgage, LLC v. Lark, 73 A.3d 1265, 1266 (Pa. Super. Ct. 2013). In this case, defendant has failed to meet his burden of proof of demonstrating circumstances warranting a setting aside of the sheriff sale. Defendant does not contest that he received notice of the Sheriff Sale as required by law. Instead, defendant complains that plaintiff, through its servicing representative, continued to work with defendant in an effort to avoid the foreclosure sale, and that these efforts resulted in defendant's belief that the sheriff sale would be stayed. In support of this position, defendant has submitted a series of correspondences between the parties that continued up to April 24, 2017 at 1:55 p.m., which was the afternoon immediately prior to the Sheriff's Sale. (Plf. Exs. 1-15.) Notably absent from these exhibits, however, is any indication that plaintiff, through its servicing representative, ever told defendant that the April 25, 2017 sheriff sale was being postponed, delayed or stayed. Indeed, the series of correspondences submitted by defendant only demonstrate that plaintiff was attempting to assist defendant in avoiding the foreclosure sale. On April 11, 2017, plaintiff, through its servicing representative, specifically informed defendant that it was unable to accommodate defendant's loan modification request. (Plf. Ex. 10.) Defendant, through the testimony of his wife, conceded that plaintiff's servicing representative never indicated that the sheriff sale would be stayed, and there is nothing on this record to suggest that plaintiff misled defendant to believe that the sheriff sale would be stayed. Defendant seeks to penalize

plaintiff for its willingness to continue working with defendant right up to the date of the sheriff sale in the hopes of finding a viable alternative to the sheriff sale. Plaintiff's decision to work with defendant to seek a means to avoid the sheriff sale is not a "proper cause" for setting aside the sheriff sale itself. If such an argument were accepted, it would have a chilling effect on the willingness of lenders to seek any alternatives to a sheriff sale after the sheriff sale had been scheduled.

Furthermore, the record is bereft of any evidence that would demonstrate that defendant has the financial ability to refinance or modify this particular mortgage, or even that there is any equity in the real property itself. The judgment totals \$425,653.69, with interest accruing at the rate of \$15.24 daily from August 12, 2016. (Praeclipe for Entry of Judgment). The original note signed by defendant in 2005 involved an initial debt of \$266,400. (Plf. Cmp., Ex A.) After 12 years, the amount due under the note has not been reduced, but has increased substantially to an amount over 60% of the original debt. In order to justify the exercise of this court's equitable powers to set aside a sheriff sale, the requirement of a showing of "proper cause" necessarily implies that such an extraordinary equitable judicial act must be more than merely a futile exercise meant only to delay the creditor's ability to collect on its debt. Defendant has failed to demonstrate: (1) that there is any equity in this real property; (2) that they have the ability to refinance this debt; (3) that plaintiff has failed to comply to any of the procedural requirements necessary for a valid sheriff sale; or (4) that plaintiff has engaged in any fraudulent or deceitful conduct. Based upon this record, defendant has simply failed to meet his burden of proof to demonstrate "proper cause" to set aside the sheriff sale.



You are hereby notified that the Susquehanna County Tax Claim Bureau pursuant to the Act of Assembly approved July 7, 1947, Act No. 542, as amended, will expose to and offer at Public Sale, commencing Monday, September 11, 2017 at 10:00 A.M., PREVAILING TIME at the Courthouse, Montrose, Pennsylvania, the hereinafter described properties, all of which are located in Susquehanna County, as hereinafter set forth:

(a) PURPOSE OF SALE:

To sell such properties against which for the year 2015 and/or prior years, a tax claim or claims have become absolute and the period of redemption has expired without the property having been redeemed or against which a tax judgment(s) has heretofore been entered under the various Acts of Assembly, which judgment has not been satisfied and/or which a sale has not been stayed by agreement in the manner hereinafter provided; or if a Stay of Sale Agreement has heretofore been entered into, a default has occurred for a period of at least ninety (90) days prior to this scheduled sale.

(b) TIME OF SALE:

Said sale will commence MONDAY, SEPTEMBER 11, 2017 AT 10:00 A.M. PREVAILING TIME AND WILL CONTINUE FROM DAY TO DAY THEREAFTER UNTIL ALL OF THE SAID PROPERTIES HAVE BEEN EXPOSED AND OFFERED TO PUBLIC SALE. IN THOSE CASES WHERE A BID IS NOT MADE EQUAL TO THE UPSET PRICE AS HEREINAFTER SET FORTH, the sale of such properties will be continued from month to month without further advertisement, as provided by law.

(c) PLACE OF SALE:

In the Susquehanna County Courthouse, Montrose, Susquehanna County, Pennsylvania, 1st floor of Courthouse.

(d) TERMS OF SALE:

CASH OR CASHIER'S CHECK for the entire purchase price as soon as the property is struck down. If the bid is not immediately paid, the sale will be voided and the property will be put up again. No sale will be made unless the bid is at least equal to the upset price. The approximate upset price is hereinafter set out after the description of each property and includes all taxes, penalties, returning fees, interest and costs as recorded in the Tax Claim Bureau and the approximate cost of this sale pro-rated. Any variation or changes in the upset price of any property will be announced at the time of the sale.

(e) AGREEMENT OF SALE:

The sale of any property may, at the option of the Bureau, be stayed if the owner thereof, before the date of the sale enters into an agreement with the Bureau to pay the taxes in installments, as follows: Twenty-five (25%) percent of the amount due on all tax claims and tax judgments filed or entered against such property and the interest on the taxes returned to date and agreeing to pay the balance of said claims and judgments and the interest thereon in not more than three (3) installments, (the first installment to

include all costs), all within one (1) year of the date of said agreement, as provided by Section 603 of the Act of Assembly, July 7, 1947, Act No. 542.

(f) REDEMPTION BEFORE SALE:

Any owner, his heirs or legal representatives, or any lien creditor, heirs, assigns or legal representatives, or other interested persons, prior to the actual sale, may redeem any property for the benefit of the owner by paying the Bureau the amount of the claim, interest and all costs as well as any other accrued taxes, penalties, and interest.

(g) CONDITIONS OF SALE:

The Bureau sells each tax parcel as the same is described on the County Assessment rolls and the dockets maintained in the Tax Claim Bureau and makes no representation or warranty as to the description of said tax parcel, nor will the Bureau make any survey on a tax parcel sold. The Bureau makes no guarantee as to the existence of any Mobile Homes subject and exposed to sale.

All tax parcels exposed to sale and sold at the upset sale are done so pursuant to the authority contained in the Pennsylvania Real Estate Tax Sale Law, Act of July 7, 1947, P.L. 1368, No. 542, as amended, 72 P.S. 5860.101 et seq. Any and all titles transferred by the Tax Claim Bureau as a result of the upset sale are under and subject to said Real Estate Tax Sale Law, and any lien or claim on any such parcel sold and title therefore transferred thereby shall be divested only as may be authorized by Section 609 of said Real Estate Tax Sale Law, as amended, 72 P.S. 5860.609. The Tax Claim Bureau expressly makes no representation and disclaims any warranty as to the title of any tax parcel hereby transferred as being unencumbered.

The purchaser or purchasers shall be required to pay the current taxes of the year 2017.

The purchaser or purchasers shall also be required to pay all costs for recording the deed, including all State and Local realty transfer taxes.

The purchaser(s) shall also be required to provide the Bureau with a certification prior to the day of the sale that, within the municipal jurisdiction, the person(s) is NOT delinquent in paying real estate taxes, and that no municipal utility bills are outstanding. Certification shall be by receipts of paid real estate taxes and municipal utility bills within the municipal jurisdiction, or by a verification stating payment of same. Verification to be executed by each purchaser prior to the day of the sale stating he or she is not a Susquehanna County elected official or appointed officer.
