**ORDER**

**NOW**, this 30th day of November, 2018, upon consideration of defendant's motion *in limine* to preclude presentation of common law bad faith claim and consequential damages and defendant's motion *in limine* to preclude presentation of breach of covenant of good faith and fair dealing, as well as the briefs submitted by the parties, **IT IS  
HEREBY ORDERED THAT:**

1. Defendant's motion *in limine* to preclude presentation of common law bad faith claim and consequential damages is **GRANTED IN PART**. See Rancosky v. Washington Nat'l Ins. Co., 170 A.3d 364, 371-373 (Pa. 2017) (providing historical background for enactment of 42 Pa. C.S. § 8371 as a response to the Pennsylvania Supreme Court's refusal to recognize a common law cause of action for bad faith in the first party context); Toy v. Metropolitan Life Ins. Co., 928 A.2d 186, 192 (Pa. 2007) (noting refusal to recognize common law cause of action for bad faith based upon the denial of insurance proceeds in first party context); D'Ambrosio v. Pennsylvania Nat'l Mut. Ins. Co., 431 A.2d 966, 969-70 (Pa. 1981) (rejecting plaintiffs' request to recognize a common law cause of action for bad faith in the first party context); O'Donnell v. Allstate Ins. Co., 734 A.2d 901, 905 (Pa. Super. 1999)(recognizing the Supreme Court's refusal to create a common law cause of action for bad faith against an insurer in first party context); Mantia v. Northern Ins. Co. of N.Y., 39 D & C 4th 71, 84 (Lancaster Cty. Court Comm. Pleas 1998) ("Finally, there are some states, such as Pennsylvania, that have no common-law bad faith, but rather have a statutorily created cause of action."); *cf. Sharp v. Travelers Personal Sec. Ins. Co.*, 36 D & C 5th 521 (Lack. Cty. Court Comm. Pleas 2014) (noting that there is no common law bad faith claim under Pennsylvania law); Myerski v. First Acceptance Ins. Co., Inc., 2016 WL 3227266, at \*9 (M.D. Pa.) (dismissing contractual claim for

breach of covenant of good faith and fair dealing because Pennsylvania did not recognize a common law contractual bad faith claim), reconsideration denied, 2016 WL 4127393 (M.D. Pa. 2016); Cicon v. State Farm Mut. Auto. Ins. Co., 2015 WL 926148, at \*2-3 (M.D. Pa. 2015) (noting that the Pennsylvania Supreme Court has refused to recognize a “contractually based bad faith claim” in cases involving “first party benefits . . . where an insurer is suing his insured”); Zeglen v. Northwestern Mut. Life Ins. Co., 2014 WL 42115531, at \*3 (E.D. Pa. 2014) (holding that claim for common law bad faith was subsumed within any breach of contract claim and not a separate cause of action); Simmons v. Nationwide Mut. Fire. Ins. Co., 788 F.Supp.2d 404, 410-11 (W.D. Pa. 2011) (finding that common law contractual bad faith claim was subsumed within a breach of contract claim allowing for recovery of compensatory damages); but see Birth Center v. St. Paul Companies, Inc., 787 A.2d 376 (Pa. 2001) (finding contractual bad faith claim based upon insurer’s failure to settle third party claim that resulted in judgment that exceeded insurance limits); Haugh v. Allstate Ins. Co., 322 F.3d 227, 236 (3d. Cir. 2003) (“[A]n insurer’s bad faith refusal to settle a [third party] claim can give rise to a contract cause of action.”); Swoboda v. Travelers Ins. Co., 2018 WL 4680131, \*3 (M.D. Pa. 2018)(finding that plaintiff can maintain both a common law and statutory bad faith claim against an insurer and that such actions are “complimentary”); Smith v. Allstate Ins. Co., 904 F.Supp.2d 515, 522 (W.D. Pa. 2012) (predicting that Pennsylvania would allow a common law bad faith contractual claim in first party insurance cases).

2. This order shall not preclude plaintiffs from presenting evidence relating to their breach of contract claim under Count 1 related to damages sustained by plaintiff Harry Phillips in the underlying automobile accident.<sup>1</sup>
3. Plaintiffs shall be precluded from presenting any evidence related to any alleged

<sup>1</sup> The parties do not contest the existence of a contractual relationship nor defendants’ obligation to provide UIM benefits. The dispute centers solely upon the extent of the injuries suffered by plaintiffs, i.e., the amount of damages. In this regard, plaintiffs will obviously be permitted to present evidence probative as to the damages suffered in the motor vehicle accident. Within the context of their breach of contract case, plaintiffs will also be permitted to present evidence of consequential damages related to severe emotional distress arising from the denial of their claim provided an adequate record is developed to support such a claim. D’Ambrosio, 431 A.2d at 970 n.5 (“The possibility cannot be ruled out that emotional distress damages may be recoverable on a contract where, for example, the breach is of such a kind that serious emotional disturbance was a particularly likely result. The present record falls short of establishing such a breach.” (citations and internal quotations omitted)); Smith, 904 F. Supp.2d at 522-23 (noting that bad faith in breach of contract action may support recovered for damages associated with “stress, anxiety, costs, embarrassment and humiliation”). Based upon the present record, the court is uncertain as to whether plaintiffs are seeking any damages arising solely out of the breach of the contract itself as opposed to the damages solely related to the underlying automobile accident that caused injuries to plaintiff Harry E. Phillips. In the complaint, plaintiffs allege damages related to “emotional distress, embarrassment and humiliation” but these allegations are set forth in the UIM count which indicates that these damages arose out of the automobile accident not any conduct by Defendant. (Plf. Cmp. ¶ 26.) No such allegations appear in the Count III (Breach of Contract) nor in Count IV (Breach of Covenant of Good Faith and Fair Dealing). To the extent that plaintiffs’ damages arising out of the motor vehicle accident exceed the policy limits, such damages are not recoverable in the breach of

bad faith conduct by Defendant unless said evidence is probative as to the damages sought in the breach of contract claim under Count 1.<sup>2</sup>

4. Defendant's motion *in limine* to preclude presentation of presentation of covenant of good faith and fair dealing is **GRANTED IN PART** consistent with the rulings set forth in paragraphs 2 and 3 of this order.<sup>3</sup>

contract action even where plaintiff are alleging that the contract was breached through bad faith conduct. See Koerner v. GEICO Casualty Co., 2017 WL 2588598, \*8 (M.D. Pa. 2017) (noting that Pennsylvania law suggests that "excess verdict damages in a third party case may be compensatory damages for purposes of a contractual bad faith claim in a subsequent suit by the insured against the insurer. However, the rational for the rule does not apply in a first party uninsured motorist coverage case.").

2 In reviewing the applicable case law, it is apparent that there is a divergence of opinion as to the existence and scope of a common law contractual bad faith claim. Plaintiffs have conceded that the existence of a common law contractual bad faith claim is questionable. (Plf. Br., at 6 ("To the extent it is unclear whether Pennsylvania currently recognizes a common law bad faith claim, Plaintiffs also assert a claim for common law bad faith in addition to Plaintiffs' claim for statutory bad faith."). Plaintiffs' complaint contains the following counts: (1) UIM; (2) Bad Faith; (3) Breach of Contract; (4) Breach of Covenant of Good Faith and Fair Dealing; and (5) Loss of Consortium. In the Bad Faith count, plaintiffs contend that defendant "violated the [insurance] policy's implied covenant of good faith and fair dealing and/or has committed the tort of bad faith, including but not limited to violating 42 Pa. C.S. § 8371. . . ." (Plf. Cmp. ¶ 31.) In this regard, there is no specific allegation of any common law contractual bad faith claim being asserted except to the extent that it would be encompassed within the breach of contract claim itself relating to the implied covenant of good faith and fair dealing. See Zeglen, 2014 WL 42115531, at \*3 ("Pennsylvania Courts have consistently held that where parties bring breach of contract claims and a common law bad faith claims simultaneously the bad faith claim sounding in contract is subsumed within the breach of contract claim."). As noted earlier, the compensatory damages arising out of such a breach in a first party insurance case would be limited by the policy limits themselves unless there is proof that the contractual breach resulted in some kind of damages to plaintiffs separate and distinct from the accident itself. On the current record, the court cannot make a final determination as to the admissibility of unknown evidence but will prohibit any evidence of contractual bad faith unless plaintiffs can demonstrate recoverable damages associated with the defendant's alleged contractual bad faith.

3 Plaintiff concedes that Pennsylvania does not recognize an independent cause of action for breach of the implied covenant of good faith and fair dealing as set forth in Count 4. (Plf. Br., at 5 ("Although Plaintiffs acknowledge that Pennsylvania does not recognize an independent claim for breach of the duty of good faith and fair dealing, such claim (and evidence supporting it) is subsumed in the breach of contract claim, and accordingly Plaintiffs must be permitted to offer testimony and present evidence or argument regarding Defendant's acts and omissions at the time of trial in relation to Plaintiffs' claims for breach of contract, uninsured motorist benefits, and bad faith."). As noted, the admissibility of such evidence would be dependent upon Plaintiffs' presenting evidence of recoverable damages arising solely out of the contractual breach as opposed to the automobile accident.
