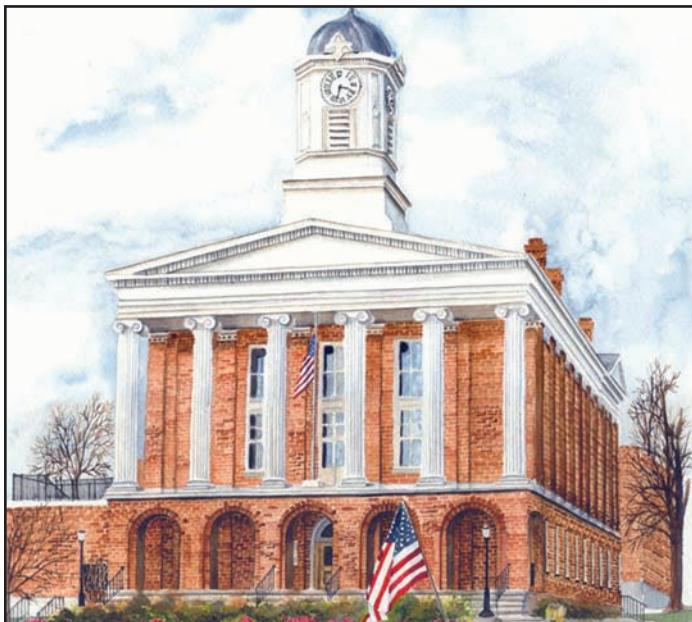

5. Duty of Care – Responsibilities of Defendant

In their trial brief, defendants contend that the only person with any legal responsibility in this matter would be the real property owner, Karen VanderGriek. In response, plaintiff continues to maintain that each of the defendants has some level of responsibility for the maintenance of the real property. The parties agree that the Court does not have a sufficient record at this point to make a legal determination as to these matters. As such, the Court will address this issue when the record has been more fully developed at trial.

6. Expert Testimony – Use of Building Codes

In their trial brief, defendants contend that any expert testimony relating to building codes should be prohibited as defendants contend that the Codes utilized by plaintiff's expert do not apply to defendants' property. Plaintiff responds by arguing that Codes are general standards of care applicable to property maintenance and should be admissible to demonstrate the appropriate construction of a stairwell. Defendants respond that such standards of care have no relevance to this matter as there is no evidence that defendants were aware of the non-applicable codes – and that allowing the expert to use these non-applicable codes would be an impermissible invasion of the jury's function.

Initially, the Court believed that it was appropriate to allow expert testimony regarding the various building codes or standards to establish a baseline for safe stairway construction. Upon further research, however, the Court now agrees with defendant's position that any reference to non-applicable building codes would be inappropriate.

The Commonwealth Court considered this identical issue in *Kiehner v. School District of Philadelphia*, 712 A.2d 830 (Pa. Comm. 1998). In that case, the plaintiff had fallen down a flight of stairs at an older elementary school. The plaintiff contended that the construction of the steps were defective – and sought to introduce expert testimony that demonstrated that the steps were not constructed to various codes. The trial court excluded any reference to code/standard violations, but permitted the expert witness to testify to his measurements and provide pictures to the jurors. In determining that the trial court properly excluded any reference to different codes or standards, the Commonwealth Court stated:

Further, the offered expert's opinion that the stairway landing was unsafe due to noncompliance with the BOCA Code and other guidelines and that the injury was caused by such unsafe condition would have misled and confused the jury and improperly impinged upon the jury's determination of the ultimate factual issue in the case. As the Supreme Court held "[t]he expert witness cannot be asked to state his opinion upon the whole case, because that necessarily includes the determination of what are the facts, and this can only be done by the jury." Hence, the trial court did not abuse its discretion in excluding the offered expert's testimony.

Id. at 833) (citation omitted).³

The Commonwealth Court also questioned the need for expert testimony in this type of case: "Moreover, the factual circumstances underlying the condition of the stairway landing in this matter are well within the common knowledge and experience of the lawperson." *Id.* at 832; *see also Burton v. Horn & Hardart Baking Co.*, 88 A.2d 873, 875 (Pa. 1952) ("Expert testimony is inadmissible when the matter can be described to the jury and the condition evaluated by them without the assistance of one claiming to possess special knowledge upon the subject.").⁴ In other words, a layperson has the requisite experience and common knowledge to evaluate whether a stairway is reasonably constructed.

In reasoning in *Kiehner* is persuasive and controlling to this situation. For this reason, the Court now agrees with defendants' position relating to the expert testimony to the extent that it relies upon any non-applicable building codes and/or standards. The Court will not permit the expert witness to testify to any non-binding building codes or standards unless defendants had an affirmative legal obligation to retrofit the staircase in question under the applicable code.

7. Medical Bills – Reasonable and Necessary

Defendants contend that the deposition of plaintiff's treating physician failed to lay a proper foundation for a bulk of the medical bills – and that plaintiff included bills that were unrelated to injuries sustained in the plaintiff's alleged fall in defendants' stairway.

³ Significantly, the Commonwealth Court noted that the school district had no obligation to comply with BOCA as the stairway was constructed prior to the adoption of BOCA standards. *Id.* at 832 ("[T]he School District had no duty to retrofit or remodel its school buildings to bring it in compliance with the current BOCA Code, which permits the existing building to continue without any change."); *see also Dilauro v. One Bala Avenue Assoc.*, 615 A.2d 90 (1992)(finding that defendants were not required to retrofit stairs to comply with new building code). The Court has not been provided with any citation or support for the proposition that defendants had a duty to retrofit these particular stairs under any applicable Code. In the absence of such a duty, there is no probative value to any recommended construction standards and the admission of such evidence would be highly prejudicial to the defendants.

⁴ *Burton* involved alleged defective steps at a commercial restaurant based upon the failure to have adhesive material and safety treads.

Plaintiff contends that some unrelated bills were inadvertently included in the bill package presented to the treating physician. Plaintiff has prepared a new bill package for trial that purportedly does not include any of the bills that were challenged by defendants at the physician's deposition.⁵ In reviewing both the newly presented bill package and the physician's testimony, the Court will allow the admission of the newly created medical bill compilation.

In particular, the treating physician did generally testify that the treatment rendered to plaintiff was reasonable and necessary. (N.T., June 6, 2014, at 25-27.) While the treating physician's testimony regarding the medical bills was poorly elicited, the record that the Court has been provided does contain sufficient evidence to infer that the medical services were reasonable and necessary to address the injuries sustained by plaintiff. *Cf. Kravinsky v. Glover*, 396 A.2d 1349, 1357 (Pa. Super. 1979) (excluding medical bills where physicians did not testify that they were reasonable and necessary and there was nothing on the record from which to infer reasonableness and necessity).



⁵ Plaintiff provided the proposed exhibit to the Court for review. The Court has reviewed that document and contrasted it to the exhibit presented at the medical expert's deposition. While the record is difficult to decipher, it appears that the plaintiff has redacted the unrelated charges from the billing documents. The Court was able to identify 4 documents that do not appear to have been presented to the plaintiff's medical expert. Prior to admission of the medical exhibits packet, the plaintiff will need to demonstrate that these documents were presented to the medical expert for his opinion that they were "reasonable and necessary." The documents are identified as follows: (2) June 6, 2007 receipt for MRI down payment; (2) Scranton Orthopedics Billing Statement with a facsimile date of April 7, 2014 identified as page 2 of 2; (3) Scranton Orthopedics Billing Statement reflecting a payment of \$105 on June 10, 2015; and (4) Barnes Kasson Invoice for MRI that includes a charge (and charge off) of \$250 for reading the MRI. As to the last exhibit, the original Barnes Kasson MRI bill was identified during the deposition testimony, but it only had the charge of \$1,182, and this bill is also in the exhibit package and was properly identified at the deposition.
