Commissioner Arnold called the Meeting to order at 9:00 a.m. in the Commissioners' Meeting Room.

Pledge of Allegiance to the Flag.

Moment of Silence

Present: Commissioners Arnold, Hall and Herschel.

Public Comment on agenda and non-agenda items:

Commissioner Hall commented about issues that have occurred with Register and Recorder's books. Progress has been made with the years of 2018 and 2019. The Commissioners were notified from the Auditors about transactions totaling \$10,000 made out to a family member. At this time, the Commissioners are turning the case over to the District Attorney and Attorney General offices. No further comments can be made.

Commissioner Hall comments about the I-81 toll plaza that is planned. It is stated that it is only a proposal and will need to go through legislation. A meeting is planned to be held Friday with PennDOT and more details will be available.

Commissioner Hall states that next week there will be a drive through COVID testing site.

Commissioner Arnold confirmed that it will be held at the Harford Fair grounds.

Commissioner Hall states that Susquehanna County will receive 2 grants. About 2.6 million will be for tenants and landlords to help with rental assistance under the Emergency Rental Assistance Program. The second grant is the Hospitality Industry Recovery Program for about \$500,000 to help restaurant and bar owners. As information becomes available, the community will be updated.

Commissioner Herschel states the Commissioners concern with the community's mental health during the pandemic. They are working with Suicide Alliance initiative. Townhalls will be held on the 4th, 11th, and 18th to bring in providers and professionals in the field to bring awareness, education, and also reduce the stigma around mental illness.

Commissioner Hall informs that they are working on a community vaccination center and thanks the fellow Commissioners for their dedication in the matter. As more information becomes available, the community will be updated.

Commissioner Herschel concurs and also thanks the medical professionals for their hard work during the pandemic.

A question is asked if employees at the courthouse were vaccinated. Commissioner Hall answered in the affirmative, stating about 60% got the vaccine during the first version of the 1a vaccine protocol. Commissioner Arnold stated that most were front line workers.

Commissioner Hall stated there would not have been a problem if we were getting the allocations. The problem was the rules were changed from population, to the number of positive cases and deaths in the county. Our community did a great job with social distancing and following CDC guidelines, our numbers were extremely low, therefore vaccines were going to the communities where numbers are high.

Commissioner Herschel states that in 4 to 6 weeks we will be receiving vaccines to distribute to the community as soon as we get the supply.

Commissioner Arnold answers in the affirmative stating that they are on the phone weekly with the Department of Health to be as prepared as possible. They are proud of the counties

employees and community in keeping everyone safe.

Commissioner Arnold congratulates Naomi Kropa for celebrating her 100th birthday yesterday. Also, stating that fire companies and non-profit business are starting their fundraisers such as, chicken barbeques, and encourages the community to support their causes.

A comment is made on the importance and need for volunteers. All Commissioners answered in the affirmative.
