ORDER

NOW, this 30th day of April, 2019, upon consideration of a petition for intervention filed by Ernest Young and Janet C. Young as well defendants' answer to the petition, and after oral argument, **IT IS HEREBY ORDERED AS FOLLOWS:**

1. Proposed Intervenor have demonstrated that they could have been included as parties in the initial litigation as it related to Count 2 (Tortious Interference with Contractual Relations).¹

¹ Proposed intervenors argue that intervention is appropriate as they could have been included as plaintiffs in the initial litigation in Count 2 relating to tortious interference with contractual relations. Pa. R. Civ. P. 2327(3). They contend that they have been damaged by defendant Lisa Wilke's alleged acts of interfering in their timber contract with Gutchess Lumber Company dated December 2014. (Plf. Cmp. Ex. H.) Indeed, proposed intervenors are the parties to the timber contract and plaintiff Janet C. Young Revocable Trust would have no interest in that particular contract. Upon the execution of the timber contract, the timber itself became personal property severed from the real property estate itself. See Hoffman v. Gongaware, 186 A.3d 453, 461 (Pa. Super. Ct. 2018) (noting Pennsylvania law that provides that a timber contract converts timber to personal property provided parties intended for immediate removal of the timber from the real property). Given the allegations in plaintiff's complaint, the timber contract intended for immediate removal of the timber from the real property. Because the timber had become personal property

severed from the real estate, it was personal property belonging to the proposed intervenors and the deed from proposed intervenors to plaintiff would not have conveyed those timber rights.

2 Based upon the allegations contained in plaintiff's complaint, defendant Lisa Wilkie sent a correspondence to Gutchess Lumber Company in June 2015 providing notice of the boundary dispute between plaintiff and defendants and that Gutchess Lumber Company thereafter refused to timber the real property. (Plf. Cmp. ¶¶ 10-11; Plf. Cmp. Ex. J.) The statute of limitations for the tort of intentional interference with contractual relations is two years. See 42 Pa. C.S. § 5524(3); Bednar v. Marino, 646 A.2d 573, 577 (Pa. Super. Ct. 1994). Based upon the plaintiff's pleadings, any tortious claim for interference with contractual relations against defendants would have expired in 2017 while the underlying litigation was not commenced until 2018. As such, the proposed intervenors cannot demonstrate that they have a legally cognizable interest in this litigation as the interference with contractual relations claim is barred by the applicable statute of limitations. See Johnson v. Tele-Media of McKean County, 90 A.3d 736, 742 (Pa. Super. Ct. 2014) (finding that party seeking intervention must present "some quantum of evidence to establish" to support a "legally recognizable claim").

While proposed intervenors contend that defendants' contractual interference is a continuing course of tortious conduct so as to avoid application of the statute of limitations, the pleadings demonstrate that the alleged interference resulted from defendants Lisa Wilkie's 2015 notification to Gutchess Lumber Company that a boundary dispute existed between the proposed intervenors and defendants. As such, the alleged contractual interference was a single act that occurred in 2015 not a continuing course of tortious conduct. See Sta-Rite Industries, LLC v. Franklin Electric Co., Inc., 519 Fed. Appx. 370, 2013 WL 1286004, at * (6th Cir. April 1, 2013) (finding that where single tortious act resulted in damages that "continuing tort exception" to 2-year statute of limitations did not apply); C & E Corp. v. Ramco Industries, Inc., 717 N.E.2d 642, 646 (Ind. Ct. App. 1999) (finding that statute of limitations on interference with contractual relations began to run when defendant sent letter that blocked payment and non-performance does not constitute a continuing course of conduct that would toll statute of limitations). Based upon plaintiff's pleadings upon which the proposed intervenors have relied, the intentional interference with contractual relations claim is time-barred and proposed intervenors have failed to present any evidence to demonstrate that they have a "legally recognizable claim" in this litigation.
