ORDER

NOW, this 6th day of January, 2016, for the reasons set forth in the attached opinion, it is hereby ordered that:

1. Defendant's motion *in limine* relating to video surveillance is **DENIED**. The admissibility of said video surveillance, or any exhibits derived therefrom, will be conditioned upon proper authentication.
2. Plaintiff's request to admit post-accident signage is **DENIED**. Plaintiff may not introduce evidence of post-accident signage for purposes of proving defendants' knowledge of a dangerous condition. In the event that ownership or control become a contested issue, plaintiff may seek to introduce the post-accident signage for the limited purpose of proving ownership/control provided that plaintiff can properly authenticate the post-accident signage.
3. Defendants' request to limit plaintiff's expert testimony to exclude any reference to inapplicable building codes or industry standards is **GRANTED**. Plaintiff's expert witness is prohibited from testifying to any building codes or other guidelines unless it can be demonstrated that said codes and/or standards were applicable to defendants and defendants had an affirmative obligation to address any alleged safety defects.
4. Defendants' objection to the introduction of plaintiff's medical bills is **DENIED**.
5. Plaintiff's motion *in limine* relating to exclusion of plaintiff's criminal history has been addressed in a separate order.
6. Plaintiff's motion *in limine* relating to exclusion of collateral source payment evidence has been addressed in a separate order.

OPINION

Based upon the pleadings, plaintiff Robert Rood, Jr., alleges that he lost his balance on a stairway, grabbed a handrail, the handrail failed, and Rood sustained injuries as a result of the fall. Rood was a tenant on a building allegedly owned, operated and maintained by defendants. Rood contends that defendants were negligent in the maintenance and operation of the stairway on the leased premises, and that he suffered injuries as a proximate result of the violation of the duty of care defendants' owed to him.

During the afternoon hours of January 4, 2016, plaintiff submitted via facsimile several motions *in limine* and a trial brief which raised an additional issue. Defendants thereafter submitted via facsimile a trial brief which raised numerous issues. Based upon the late nature of these submissions, the Court was unable to address them prior to jury selection, which occurred on the morning of January 5, 2016. Immediately following jury selectin, the Court conducted a conference relative to these outstanding issues. Several of the issues presented were resolved at that conference while others were taken under advisement by the Court.

1. Plaintiff's Motion *In Limine* – Criminal History

Plaintiff sought to preclude the defendants from referencing or attempting to introduce his criminal history. Based upon the representation in plaintiff's brief, defendant had some kind of prior interaction with the criminal justice system, but it was represented that the criminal history information is now expunged. As such, it is not clear that any criminal records relating to the plaintiff even exist at this point. In any event, defendants indicated that they were not seeking to admit any criminal history information. For this reason, the Court granted the motion in limine relating to the plaintiff's criminal history by separate Order.

2. Plaintiff's Motion *In Limine* – Collateral Source

Plaintiff sought to preclude the defendants from seeking to introduce any evidence of collateral source payments to the defendant from third parties. Defendants conceded that they were not seeking to admit any such evidence - except to the extent that it may relate to the payment of medical bills by third parties, which plaintiff conceded was proper. Based upon this agreement, plaintiff's motion in limine relating to collateral source payments was granted by separate order.

3. Plaintiff's Motion *In Limine* – Video Surveillance

Plaintiff sought to exclude the use of a video surveillance tape on the grounds that the videographer is deceased. Defendants were not aware if the videographer was deceased, but indicated they did not intend on playing or using the video itself at trial. Rather, defendants had taken certain pertinent portions of the surveillance video and created still photographs for use at trial. Defendants intend to present said still photographs to plaintiff during cross-examination. The use of a still photograph, rather than the video, does not alleviate the need for proper authentication. "When the evidence in question is a photograph, it may be authenticated by testimony from a person who has sufficient knowledge that the photograph fairly and accurately reflects what the proponent is purporting that the photograph reflects." *Commonwealth v. Loughnane*, 2015 WL 7432463, at *5 (Pa. Super. Nov. 23, 2015). Given the death of the videographer, the defendants do not have a person who can testify as to how the photograph was produced and that it does fairly and accurately depicts anything.

The Court determined that the photographs could be used for impeachment purposes to the extent that the defendants were able to get the plaintiff to authenticate the photographs during cross-examination. While not binding precedent, *Dunn v. Bank-Tec South*, 134 S.W.3d 315 (Tex. Ct. App. 2003) is instructive. In that case, the plaintiffs sought damages in a negligence action against a bank as a result of injuries sustained in an accident at one of the bank's mobile teller units. The defendant presented a surveillance video at trial – but did so during the cross-examination of the plaintiff. The defendant did not provide any independent authentication testimony from the videographer. In rejecting the claim that the video was improperly admitted without proper authentication, the Texas Court of Appeals stated:

[T]he admissibility of the video is conditioned upon its identification by a witness as an accurate portrayal of the facts and on verification by that witness or a person with knowledge that the photograph is a correct representation of such facts. Furthermore, its accuracy or authenticity need not be established by the videographer; any person may do so if he observed the object or scene depicted and can testify that the video is an accurate portrayal of the facts. Here, the video was presented during cross-examination of [the plaintiff]. He not only agreed that he was the person filmed but also described the things he was doing in it. In other words, his testimony effectively supplied the predicate for the video's admission by revealing that its content was an accurate portrayal of the acts he was doing. Thus, we cannot say that the item was unauthenticated and, therefore, inadmissible.

Id. at 329 (citations omitted). The Court agrees with Dunn and finds that the still photographs derived from the video surveillance may be admitted at trial provided defendants are able to properly authenticate those still photographs during the cross-examination of the plaintiff. For this reason, plaintiff's motion *in limine* seeking exclusion of the video surveillance will be denied.¹

4. Past-Incident Conduct – Warning Signage

The plaintiff also seeks to introduce a sign that was allegedly posted at the subject property by defendant Charles Rohan on August 30, 2007 representing that the stairs were defective and dangerous. In this regard, plaintiff's fall occurred on May 30, 2007. Plaintiff concedes that such evidence is not admissible to demonstrate negligence as such use is prohibited under Pennsylvania Rule of Evidence 407 (Subsequent Remedial Measures). Plaintiff contends that this signage demonstrates that defendants had knowledge that the stairs were dangerous.

"Evidence is relevant if it has any tendency to make a fact more or less probable than it would be without the evidence[,] and the fact is of consequence in determining the action." Pa. R. Evid. 401. To state it another way, "[e]vidence is relevant if it logically tends to establish a material fact in the case, tends to make a fact at issue more or less probable or supports a reasonable inference or presumption regarding a material fact." *Commonwealth v. Tyson*, 119 A.3d 353, 358 (Pa. Super. 2015). Plaintiff contends that the post-fall signage demonstrates that defendants had knowledge of the dangerous condition. Admittedly, such signage is authentic (which defendants likewise dispute), it would demonstrate knowledge of a dangerous condition from the moment the signage was posted and anytime thereafter. The fundamental problem with plaintiff's argument is that it seeks to impute upon defendants pre-fall knowledge based upon post-fall conduct. The offered evidence cannot support a reasonable inference that defendants had knowledge of any dangerous condition prior to plaintiff's fall as the posting did not occur until several months after plaintiff's fall. Based upon the timing of the notice, the Court finds that is not relevant to the issue of defendants' knowledge of any dangerous condition prior to plaintiff's fall.

Because the Court determines that the post-fall signage is not relevant, the plaintiff will be prohibited from introducing it at trial for purposes of demonstrating that the defendants had knowledge of a dangerous condition prior to the fall.

In the alternative, plaintiffs contend that the post-accident signage is admissible to demonstrate ownership or control of the property. This would be a permissible use of such evidence under the exceptions to Rule 407 provided that his becomes a contested issue. *See West's Pennsylvania Evidence* § 407-2(a) (Packel Poulin 4th Ed. 2013).²

The Court Opinion will be continued in the next issue.

1 In reviewing the transcript of Dr. Christopher Metzger provided to the Court by the plaintiff, the plaintiff's medical expert testified to reviewing the video surveillance and provided testimony regarding the plaintiff's activities captured in the video. (N.T., June 6, 2014, at 27-28.) While this does not independently authenticate the contents of the video, it demonstrates that the parties were contemplating the use of the video surveillance in some manner at trial.

2 Further, even assuming that ownership or control becomes an issue during the trial, the plaintiff would still have to properly authenticate the post-accident signage prior to any admission of such testimony. In this regard, plaintiff proffered a hand-written printed sign that purportedly was placed at the property after the accident signed "Charlie." Plaintiff contends that "Charlie" would be defendant Charles Rohan. Based upon representations made at the conference, defendant Charles Rohan denies that he wrote or posted the sign, he denies that the sign was in his hand-writing, and he contends he never uses the name "Charlie." Thus, it is not clear that even if ownership/control becomes an issue as to how the plaintiff will properly authenticate the proffered exhibit.


