III. Discussion

a. Standard of Review

Summary judgment is appropriate “where the record clearly demonstrates that there is no genuine issue of material fact and that the moving party is entitled to judgment as a matter of law.” Summers v. Certainteed Corp., 997 A.2d 1152, 1159 (Pa. 2010) (citing Pa.R.C.P. No. 1035.2(1)). In reviewing a motion for summary judgment, the court must consider all facts (and any reasonable inferences deducible therefrom) in a “light most favorable to the non-moving party.” Id. Any doubts must be resolved in favor of the non-moving party and, for this reason, summary judgment is only proper where the record is “clear and free from all doubt.” Id. This is not to suggest that the non-moving party bears no burden; rather, the non-moving party must still “adduce sufficient evidence on an issue essential to his case and on which he bears the burden of proof such that a jury could return a verdict in his favor.” Burlington Coat Factory of Pennsylvania, LLC v. Grace Const. Mgmt. Co., LLC, 126 A.3d 1010, 1017-18 (Pa. Super. Ct. 2015). If a non-moving party fails to present such evidence demonstrating a question of material fact, then summary judgment will be granted to the moving party. Id.¹

b. Defendant Woodruff’s Motion for Summary Judgment

1. Negligence

Woodruff’s summary judgment motion centers on the assertion that there is no evidence of record suggesting that he had any duty other than to drive the truck once the rodeo bulls were loaded by Finch onto Finch’s trailer. The Schencks, in opposition to the motion, contend that since Woodruff parked the trailer in such a way as to prevent the closing of the arena gate, Woodruff is liable for their injuries

In order for liability to be imposed upon a defendant in a negligence action, the plaintiff must establish the following four elements: (1) the existence of a duty or obligation recognized by law; (2) a failure on the part of the defendant to conform to that duty, or a breach thereof; (3) a causal connection between the defendant’s breach and the resulting injury; and, (4) actual loss or damage suffered by the complainant. T.A. v. Allen, 669 A.2d 36 (Pa. Super. Ct. 1995). “[A] duty or obligation recognized by the law, requiring the actor to conform to a certain standard of conduct” is the first element of negligence. Atcovitz v. Gulph Mills Tennis Club, Inc., 812 A.2d 1218, 1222 (Pa. 2002). Duty, in any given situation, is predicated upon the relationship existing between the parties at the relevant time. Zanine v. Gallagher, 497 A.2d 1332, 1334 (Pa. Super. Ct. 1985). Where the parties are strangers to each other, such a relationship may be inferred from the general duty imposed on all persons not to place others at risk of harm through their actions. Id. Furthermore, “duty arises only when one engages in conduct which foreseeably creates an unreasonable risk of harm to others.” R.W. v. Manzek, 888 A.2d 740, 747 (Pa. 2005). “Whether a defendant owes a duty of care to a plaintiff is a question of law.” Huddleston v. Infertility Ctr. of Am., Inc., 700 A.2d 453, 457 (Pa. Super. Ct. 1997) (citing Kleinknecht v. Gettysburg College, 989 F.2d 1360, 1366 (1993)).

¹ An issue of material fact is in genuine dispute if the evidence is such that a reasonable jury could return a verdict for the nonmoving party. Anderson v. Liberty Lobby, Inc., 477 U.S. 242, 248 (1986).

There is no dispute that the contract between HAS and Finch required Finch to provide all personnel and stock for the rodeo and house and secure the bulls. Finch, in his response to a request for admissions, admitted that he – not Woodruff – provided the bulls for the event and was responsible for transporting them to and from the event. Woodruff had no responsibility for the rodeo, the arena, the containment area, the Fair, the fairgrounds or anything that would have prevented this incident. In reviewing these circumstances, the Schencks' expert witness did not provide an opinion as to any negligent acts of Woodruff that contributed to this incident.

The undisputed record demonstrates that Woodruff was hired for one purpose – to haul a trailer to and from the fairgrounds. Woodruff did not have any supervisory authority in the manner in which the bulls were loaded or unloaded. Woodruff simply drove to the location he was directed and waited for further instruction. The record fails to demonstrate any conduct by Woodruff which foreseeably created an unreasonable risk of harm to others.

The failure of a third party to close a gate on another's property which then allowed an animal to escape does not constitute a negligent act. In Williams v. City of New York, 306 A.2d 203, 207 (N.Y. App. Div. 2003), a contractor left a gate opened that allowed the owner's dog to escape and roam the streets. The dog ended up chasing the plaintiff who was struck by a motor vehicle as the plaintiff was fleeing. In assessing these facts, our sister court explained that the contractor could not be held liable for the injury where he did not own the dog or otherwise have control over the dog or the property where the dog was kept. *Id.* at 224-25; see also Bridgett v. Orkin Exterminating Co., Inc., 826 S.W. 86, 88 (Mo. Ct. App. 1992) (finding exterminator not liable for dog's death after he left fence gate open as property owner had duty to check fence gate before letting dog out of dog run). Likewise, in this case, Woodruff was not the owner of the rodeo bulls. Woodruff had no power or control over the rodeo bulls. Moreover, Woodruff did not own the real property where the bulls were being housed. Woodruff – like the contractor in Williams – was a third party unconnected with the rodeo bulls. Woodruff was responsible for transportation only and the record fails to show any facts that would have created a legal duty upon Woodruff as it relates to the handling of the rodeo bulls.

Considering all facts and any reasonable inferences deducible therefrom in a light most favorable to the Schencks, the record is devoid of any evidence that imposed a duty upon Woodruff relative to the handling of the rodeo bulls or evidence that Woodruff violated a duty by following Finch's direction as to where to park his truck with Finch's trailer. The Schencks have failed to make out a *prima facie* cause of action for negligence against Woodruff as they have failed to show that Woodruff owed them any duty. Woodruff's Motion for Summary Judgment is granted as to the Schencks' negligence claim.

2. Negligent Entrustment

Woodruff contends that there is no evidence to support the allegation of the Schencks that their injuries were caused by the negligent conduct of Woodruff in entrusting Finch with their trailer and their animals when they knew or should have known that Finch was incapable of properly handling the animals and did not have proper safety measures in place to prevent the escape of the animals.

The tort of negligent entrustment is defined by the Restatement (Second) of Torts § 308 which states:

§ 308. Permitting Improper Persons to Use Things or Engage in Activities

It is negligence to permit a third person to use a thing or to engage in an activity which is under the control of the actor, if the actor knows or should know that such person intends or is likely to use the thing or to conduct himself in the activity in such a manner as to create an unreasonable risk of harm to others.

Section 308 imposes liability on a defendant because of his own acts in relation to an instrumentality or activity under his control. Christiansen v. Silfies, 667 A.2d 396, 400 (Pa. Super. Ct. 1995).

The record established that Finch owned the rodeo bulls and the trailer that transported the bulls. The Schencks have produced no evidence that Woodruff entrusted anything to Finch – let alone negligently entrusted his property to Finch. Given that the Schencks have not produced sufficient facts to make out a *prima facie* cause of action in negligent entrustment where there is no evidence showing that Woodruff provided the bulls or any equipment used in the rodeo, there is no issue to be submitted to the fact-finder and Woodruff's Motion for Summary Judgment will be granted on the negligent entrustment claim.

c. Defendant HAS and Harford Fair's Motion for Summary Judgment

1. Negligence

HAS and Harford Fair contend that they are entitled to summary judgment as plaintiffs have not shown what caused the latch on the gate to open or that this resulted from HAS and Harford Fair's negligence rather than from some other circumstance beyond HAS and Harford Fair's control. The Schencks, in opposition to the motion for summary judgment, assert that even though HAS and Harford Fair argue that they had nothing to do with the running of the rodeo and loading of the bulls, a material question of fact exists as to whether HAS and Harford Fair fulfilled their duty of care as it relates to protecting Fair patrons from the danger of the escaped rodeo bulls. The Schencks, as well as plaintiffs Kravchenko and Kwiatkowski, also assert that there remains a question as to the negligence of HAS and Harford Fair in regards to the defendants' actions following the escape of the bulls which led to the single bull running into the Midway, i.e., the suggestion that HAS employees chased the one bull thereby causing it to enter the Midway area.

"The standard of care which a possessor of land owes to an entrant upon the land depends upon whether the entrant is a trespasser, licensee, or business invitee." Trude v. Martin, 660 A.2d 626, 630 (Pa. Super. Ct. 1995). A business invitee is a "person who is invited to enter or remain on land for a purpose directly or indirectly connected with the business dealings with the possessor of the land." Restatement (Second) of Torts, § 332 (1965); accord T.A. v. Allen, 669 A.2d 360, 363 (Pa. Super. Ct. 1995). "The duty owed to a business invitee is the highest duty owed to any entrant upon land. The landowner is under an affirmative duty to protect a business visitor not only against known dangers but also against those which might be discovered with reasonable care." Charlie v. Erie Ins. Exch., 100 A.3d 244, 253 (Pa. Super. Ct. 2014) (citing Emge v. Hagosky, 712 A.2d 315,

317 (Pa. Super. Ct. 1998)). “It is a general rule that a possessor of land has a duty (1) to use reasonable care to make the premises safe for the use of persons invited to use the premises for business or (2) to give them adequate and timely warning of dangers known to him but unknown to the business invitees.” Crane v. I.T.E. Circuit Breaker Co., 278 A.2d 362, 363 (Pa. 1971). Furthermore, an owner and operator of a fair has a duty to keep the premises in a reasonably safe condition for its invitees. St. Germain v. Dutchess Cty. Agric. Soc’y, 274 A.D.2d 146, 150 (N.Y. App. Div. 2000)(holding that agricultural society was not entitled to summary judgment where a triable issue of fact existed as to whether the society should have taken precautions to minimize contact between fairgoers and heifers to prevent plaintiffs being trampled by a cow which broke free from its handler and ran amongst fairgoers as it was being led from an exercise area to a barn at the fair.)

Dr. Kowaleski stated that the Fair’s arena is surrounded by a chain link fence which is a safety precaution to protect patrons of the Fair. The arena supervisor, Kulick, testified that the arena is a contained area when the north and south gates are closed. It is undisputed that the north gate was open and that the rodeo bulls escaped through the open gate that was in the custody and control of HAS and Harford Fair. Kulick further testified that HAS normally has two security personnel stationed at the arena but at the time the bulls were being loaded, no security personnel were present in the arena. Additionally, the Schencks’ expert, Lucenko, opined that Harford Fair failed to establish an appropriate risk management and safety plan and that Fair employees contributed to the injuries when they chased the bulls on four-wheelers despite having no training on how to handle such a situation.

HAS and Harford Fair argue that because no evidence was presented showing how the gate opened to initially release the bulls, there are no facts upon which a jury could find negligence on the part of HAS or Harford Fair. However, HAS and Harford Fair had a duty to use reasonable care to make the premises safe for the fairgoers. While the initial failure of Finch’s gate latch allowed the rodeo bulls to escape Finch’s control, the bulls then ran through the arena gate that was controlled by HAS and Harford Fair. There is further evidence that employees of HAS and Harford Fair “chased” the bull that ended up going through the Midway area and injuring plaintiffs. HAS and Harford Fair had knowledge that a rodeo event was occurring. HAS and Harford Fair had enclosed its arena area for the very purpose of protecting patrons from hazards created by different Fair events. HAS and Harford Fair allowed its north gate to remain open despite its knowledge of the dangers of rodeo bulls and the need to contain the rodeo bulls. A reasonable jury could conclude that HAS and Harford Fair failed to exercise reasonable care to protect its patrons by allowing the north gate to remain open despite having knowledge that rodeo bulls were being loaded in the arena area. In light of this evidence, a triable issue of fact exists as to whether HAS and Harford Fair failed in their duty to keep the premises in a reasonably safe condition for the patrons of the Harford Fair. HAS and Harford Fair’s motion for summary judgment will be denied.
