**OPINION**

**I. Statement of Facts**

On November 28, 2014, Defendant Virginia O'Hara ("O'Hara") sustained fire damage to her home at 860 Lake Road, New Milford, Susquehanna County, Pennsylvania. (Pl.'s Cmp. ¶¶ 2, 4.) Plaintiff Sepco Inc. d/b/a Servpro ("Servpro") is a business that provides cleaning and restoration services with its principal place of business located at 134 Conklin Avenue, Binghamton, New York. (*Id.* ¶¶ 1, 3.) On December 13, 2014, O'Hara signed an Authorization to Perform Services ("contract") with Servpro for the cleaning and restoration of her Lake Road property as well as for the removal and cleaning of her personal property items at a remote location. (*Id.* ¶¶ 5, 7, 8; Pl.'s Cmp. Ex. A.) The contract required O'Hara to make any claims for faulty performance, nonperformance or breach of contract in writing within 60 days after completion of services and to institute any breach of contract action within one year. (*Id.* ¶ 17.)<sup>1</sup> O'Hara was insured by USAA Casualty Insurance Company ("USAA") at the time of the fire and agreed to pay an insurance deductible of \$1,000 as well as any amounts not covered by her insurer to Servpro. (*Id.* ¶¶ 9, 10, 11; Pl.'s Cmp. Ex. A.) O'Hara also agreed to pay Servpro any money received by her from USAA immediately

1 The contract, under "Terms and Conditions of Service," states the following:

Any claim by Client for faulty performance, for nonperformance or breach under this contract shall be made in writing to Provider within sixty (60) days after completion of services. Failure to make such a written claim for any matter which could have been corrected by Provider shall be deemed a waiver by Client. NO ACTION, REGARDLESS OF FORM, RELATING TO THE SUBJECT MATTER OF THIS CONTRACT MAY BE BROUGHT MORE THAN ONE (1) YEAR AFTER THE CLAIMING PARTY KNEW OF OR SHOULD HAVE KNOWN OF THE CAUSE OF ACTION.

(Plf. Cmp. Ex A, ¶ 7.)

after she received a check from USAA. (*Id.* ¶ 12; Pl.'s Cmp. Ex. A.) Servpro preformed the restoration and cleaning work for O'Hara. (*Id.* ¶ 13.) On January 30, 2015, USAA issued a check for \$23,584.33 which was made payable to O'Hara and Servpro. (*Id.* ¶ 21; Pl.'s Cmp. Ex. C.) On February 16, 2015, Servpro sent O'Hara an invoice for the work performed in the amount of \$24,584.33. (*Id.* ¶¶ 14, 15; Pl.'s Cmp. Ex. B.) Servpro has not received payment from O'Hara nor has O'Hara notified Servpro in writing of any claims for faulty performance, nonperformance or breach of contract. (*Id.* ¶ 16, 18.)

## **II. Procedural History**

On September 29, 2015, Servpro filed this action for breach of contract (Count I), and unjust enrichment (Count II) contending that O'Hara's failure to pay Servpro for the services performed and to endorse the USAA check to pay Servpro is a breach of contract. Servpro also asserts that O'Hara was unjustly enriched where she received services but failed to pay for those services. Servpro requested attorney's fees as provided for pursuant to the terms of the contract. On February 5, 2016, O'Hara filed preliminary objections to Servpro's complaint contending that Servpro: (1) failed to attach the contract as required by Pennsylvania Rule of Civil Procedure 1019(i); (2) failed to establish there was an agreement for payment of attorney's fees; and (3) failed to plead the necessary elements for a breach of contract action.<sup>2</sup> O'Hara subsequently withdrew her preliminary objections. On July 28, 2017, O'Hara filed an Answer to Servpro's complaint with new matter and a counterclaim.

In her counterclaim, O'Hara asserts claims for negligence and breach of contract, contending that certain personal property items that were to be restored by Servpro have not been returned to her and that certain personal property items were substantially damaged by Servpro. (Def.'s Counterclaim ¶¶ 60, 62, 63.) She alleges that the loss sustained for this damage is \$10,969,256.32. (*Id.* ¶ 63; Def.'s Exs. C, D & E.) On August 22, 2017, Servpro filed an answer to O'Hara's new matter, asserting, in part, that O'Hara's claims are waived pursuant to the terms of the contract and that her claims are barred by the statute of limitations set forth in the contract. On May 23, 2018, Servpro filed a motion for summary judgment as to O'Hara's counterclaims, asserting that O'Hara failed to preserve her rights pursuant to the contract she entered into with Servpro because (1) she failed to provide written notice identifying any claim within 60 days and (2) she failed to bring a claim within one year as set forth in the contract. Oral argument was held on October 23, 2018 and both parties have now submitted briefs arguing their respective positions. The matter is now ripe for disposition.

## **III. Standard of Review**

Summary judgment is appropriate "where the record clearly demonstrates that there is no genuine issue of material fact and that the moving party is entitled to judgment as a

<sup>2</sup> On March 6, 2016, O'Hara filed for bankruptcy. Argument on O'Hara's preliminary objections initially scheduled for July 12, 2016 was continued pending the outcome of the bankruptcy proceedings. On March 8, 2017, the bankruptcy action was dismissed by the United States Bankruptcy Court for the Middle District. Argument on the preliminary objections was scheduled for April 18, 2017. On April 17, 2017, O'Hara filed a Praeclipe to withdraw her preliminary objections.

matter of law.” Summers v. Certainteed Corp., 997 A.2d 1152, 1159 (Pa. 2010) (citing Pa.R.C.P. No. 1035.2(1)). In reviewing a motion for summary judgment, the court must consider all facts (and any reasonable inferences deducible therefrom) in a “light most favorable to the non-moving party.” Id. Any doubts must be resolved in favor of the non-moving party and, for this reason, summary judgment is only proper where the record is “clear and free from all doubt.” Id. This is not to suggest that the non-moving party bears no burden; rather, the non-moving party must still “adduce sufficient evidence on an issue essential to his case and on which he bears the burden of proof such that a jury could return a verdict in his favor.” Burlington Coat Factory of Pennsylvania., LLC v. Grace Const. Mgmt. Co., LLC, 126 A.3d 1010, 1017-18 (Pa. Super. Ct. 2015). A record that supports summary judgment will either (1) show the material facts are undisputed or (2) contain insufficient evidence of facts to make out a *prima facie* cause of action or defense and, therefore, there is no issue to be submitted to the fact-finder. Yenchi v. Ameriprise Financial, Inc., 123 A.3d 1071, 1077 (Pa. Super. 2015) (citing DeArmitt v. N.Y. Life Ins. Co., 73 A.3d 578, 586 (Pa. Super. 2013)). If a non-moving party failed to present such evidence demonstrating a question of material fact, then summary judgment will be granted to the moving party. Id.
